




ORLEANS COUNTY, NY VISITOR SPENDING

Visitor spending in Orleans County significantly contributes to our local economy. The tourism industry supports various local businesses, including lodging, dining, and recreational activities. From the historic Erie Canalway Trail to year-round world-class fishing, Orleans County attracts a considerable number of tourists.

Promoting the natural beauty of Orleans County, historical sites, and local events has played a vital role in attracting tourists and fueling economic growth.

Greater Niagara Region

Visitor Spending by County Percentage of visitor spend



- In 2023, visitor spending and tourism-related employment grew to \$3.8 billion and 48,587 jobs, respectively.
- Visitor spending in the Greater Niagara region increased by 11% relative to 2022.
- Leading the overall visitor spending improvement was Orleans County with recorded 12% growth versus 2022.
- The share of visitor spending accounted for by Niagara County was 29% in 2023.
- Erie County represents 64% of the region's tourism sales, with \$2.4 billion in direct tourism spending.

Tourism Promotion Agency (TPA) budget depends on revenues from:

Orleans County

- 4% Occupancy (Bed) Tax collected
- Travel Guides & Co-op/Partnership Ad Sales

I Love NY

- Matching Funds program- \$3.45 million available to 62 counties (2024)
- Used to assist with Tourism marketing to reach new market areas that sustain/boost overnight visitation








VISITOR SPENDING

Orleans County Bed Tax (4% Tax on Lodging, implemented in 2003)

The Orleans County Tourism budget is dependent on bed tax collected from local lodging businesses. It is used to leverage I Love NY Matching Funds which goes towards advertising, design, printing, media buys, consumer shows, and distribution of marketing materials. Bed tax applies to an apartment, hotel, motor court or inn, boarding house, cabin, cottage or club, bed and breakfast, inns and tourist homes, or similar hotel or motel type of accommodations for a stay less than 30 consecutive days.

*Visitor spending is calculated by adding lodging, food and beverage, retail and gas stations, transportation, recreation, and entertainment together.
